SCHEDULE "L" – PRIVATE OUTDOOR LIGHTING RATE

TYPE OF SERVICE

Permanent area outdoor lighting, energized by single-phase, 60 cycles, at available standard voltage of 120 volts.

AVAILABILITY AND CONDITIONS OF SERVICE

Available to any Member in good standing subject to the following conditions:

1. EECA shall install, own and maintain all lights installed under this agreement.
2. Light shall be installed on an EECA pole that is readily accessible for maintenance.
3. Light shall be unmetered and billed in accordance with the rate schedule given herein.
4. Monthly rates will not be pro-rated for service outages.
5. Member shall provide easement for the installation of the light and provide access to all equipment at all reasonable hours for the purpose of inspecting and maintaining equipment.
6. Maintenance of lights shall be routinely scheduled during normal working hours at the EECA's convenience.
7. The member shall be required to pay for replacements due to vandalism or willful destruction.
8. For member requesting lighting at locations other than locations where EECA has available facilities, the member shall pay the installation, labor and materials charges for all equipment based on the current line extension policy.

SERVICE CHARACTERISTICS

An outdoor lighting service using lamps and equipment available under this schedule. This includes photoelectric control equipment, lighting fixture, mast arm, and where needed, one pole and up to 150 feet of service drop. Availability of lighting types may vary based on manufacturer available and may not be available at all times. Conventional lights (mercury vapor or high pressure sodium) are no longer available for new installations.

RATES FOR SERVICE

<u>Fixture Type</u>	<u>Monthly Rate (per light, per month)</u>	
100 Watt Sodium light	\$ 10.00	(Existing ONLY)
175 Watt Mercury Vapor light	\$ 10.00	(Existing ONLY)
250 Watt Sodium light	\$ 14.00	(Existing ONLY)
400 Watt Sodium light	\$ 17.00	(Existing ONLY)

All new lighting fixtures installed after January 1, 2017 will be energy efficient Light Emitting Diode - LED light fixtures, priced at the following:

<u>Fixture Type</u>	<u>Monthly Rate (per light, per month)</u>
50 W LED – SMALL LED	\$ 10.00
100 W LED – LARGE LED	\$ 14.00

TAX ADJUSTMENT

The amount computed at the above monthly rate shall be subject to taxes, assessments, and surcharges imposed by any governmental authority.

MONTHLY CHARGE

The area light charge will be billed separately on the member's regular bill and shall be due at the same time and on the same terms as the member's regular bill.

TERMINATION OF SERVICE:

The member may request termination of lighting service at their option and EECA may remove its property upon such notice with reasonable diligence. Member requesting a different type, size, or style of fixture will be charged the removal and installation costs for this request.

EECA may remove its fixture and cancel security lighting service whenever such action is necessary to protect EECA from fraud or abuse.

This schedule of rates shall be effective for March 2018 usage.
