Section 4. The undersigned (hereinafter called the ‘Applicant’) hereby applies for membership in and agrees to purchase electric power from Egyptian Electric Cooperative Association (hereinafter called ‘EECA’) upon the following terms and conditions:

- Applicant agrees to comply with and be bound by the Articles of Incorporation and By-laws of the Cooperative and any amendments thereto, and such rules, policies and regulations as may be adopted from time to time by the Cooperative.

- Applicant agrees that all electric power used on the premises will be purchased from EECA and will be paid for at times and rates to be determined from time to time by the Board of Directors of EECA.
- Applicant agrees: 1. to deposit with EECA such consumers' deposit as is required by the rules and policies of EECA; it being expressly understood that such deposit shall be non-interest bearing and that any portion of said deposit not applied to payment of bills due EECA shall be refunded to Applicant upon termination of receiving electric power in accordance with Policy 104 (see attached). 2. to deposit any such fee as is designated by EECA's rules and policies which are incidental to providing electric power at the service connection. 3. to cause the premises to be wired in accordance with wiring specifications and codes as approved by the State of Illinois and area communities.
- Acceptance of this application by EECA shall: 1. Constitute a contract for electric service between Applicant and EECA which shall continue in force from date of this application (subject to termination of membership) until cancelled. 2. Constitute an acceptance of Applicant to membership in EECA with such rights and liabilities as are specified in the By-laws of the Cooperative, provide however, that said membership shall terminate when Applicant ceases to purchase electric power from EECA, and said membership shall terminate in any other manner set forth in the By-laws of the Cooperative or such rules and regulations as are adopted from time to time by the Board of Directors.
- Applicant, by becoming a member, assumes no personal liability or responsibility for any debts or liabilities of EECA, and it is expressly understood that under law his private property cannot be attached for any debts or liabilities of EECA.
- Applicant, if accepted as a member of the Cooperative, hereby authorizes EECA to cancel said membership upon termination of membership of Applicant in any manner.
- Applicant hereby permits authorized agents of EECA access to the property and premises of the Applicant for the purpose of inspecting, repairing, replacing, or removing property and equipment of EECA. EECA shall have the right, but shall not be obligated, to inspect any installation before electric service is introduced, or at any later time, and reserves the right to reject any wiring or electric apparatus not in accordance with applicable codes.
